In Memoriam Dennis Michael Herndon 1953 - 2017



The barbershop lost one of it's strongest supporters and hardest workers in Dennis Herndon in 2017. After a short illness, Dennis passed away on December 24. Dennis was a fine gentleman, a tireless worker and director for the Archie Edwards Blues Heritage Foundation. He could usually be found on Saturdays sitting at the back of blues jams with his guitar working on his fingerstyle guitar technique. He would play quietly so as not to be heard or disrupt the jam - that was Dennis' way. He possessed a big heart, true selflessness and an easygoing manner. He carried his martial arts philosophy into his daily life, he had time for everyone and put others before him. In addition to his duties as secretary to the board of directors, Dennis maintained the website, facebook pages and booked many of the musicians who performed at the barbershop. Obituary

Dennis Michael Herndon was born June 5, 1953, to Raymond Everett and Elsie Mae Herndon in Detroit, Michigan. After losing both parents at a young age, he was raised by his maternal grandmother, Lulu Mae Honeybus.

Dennis graduated from Central High School in 1970 and attended Wayne State University. He began his broadcasting career at WDET Public radio in Detroit in 1977. In 1978 he became a broadcast technician with NPR and moved to Washington D.C. He worked as an audio engineering manager at NPR from 1980 until he retired in 2015. He subsequently returned to his hometown of Detroit.

In 1979 Dennis met Daisy Brown, who followed him from WDET to NPR in 1980. They married in November, 1981 in Washington D.C. Their daughter, Lynette was born a year later followed by a son, Maikil born in July, 1984. They divorced in 1997 but remained amicable co-parents. Dennis was very active in the lives of his children and their friends volunteering with the Cub Scouts, Girl Scouts and other activities. Dennis was also a black belt in Kempo karate and enjoyed teaching classes with the Polander Academy of Martial Arts in Bethesda, MD. Dennis loved all of the arts including TV and film. he was a gifted musician who could often be found playing his guitar on Saturdays with the Archie Edwards Blues Barbershop where he also served as webmaster and board member.

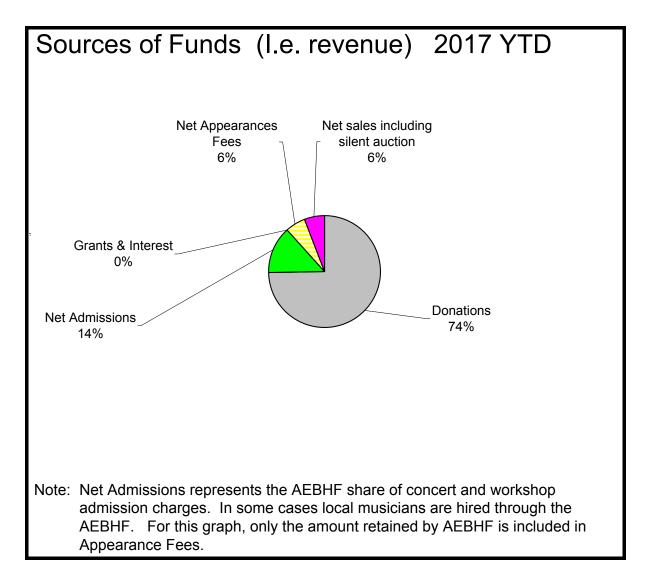

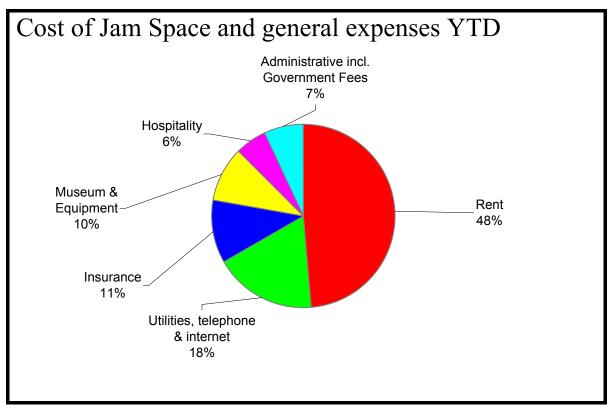

^{1/} The portion of checks received for Augusta Blues and Swing Week that represents a donation are included with donations. Some of these donations were designated for the Augusta Heritage Youth Scholarship Fund. Such amounts are donated to Augusta by by AEBHF and are included as grant outlays. The remainder represents tuition, room deposits, and refunds if any. Receipts from students are matched by an account payable until tuition actually is remitted. The books show a receivable if students have not yet paid.

^{2/} Payments to performers and sound techs can occur at both AEBHF events and outside events. At most AEBHF concerts, and workshops, performers got at least 80% of ticket sales. These payments are shown as expenses.

^{3/} Costs of producing CDs and merchandise for sale are expensed, as are outlays for sound equipment, furniture and collection items.
